\_\_\_\_\_ Clients are required to thoroughly shower and shampoo before floating. If a client contaminates the pool in any way they will be required to pay the cost of cleanup and refilling the pool with salt. (\$500.00-\$1,500.00 depending on the current cost of supplies)

I understand that the Floatation Tank uses:

\*Pharmaceutical grade Epsom salts

\*Ultraviolet sterilization system

\*Natural enzymes and non-toxic biodegradable cleaning products

\*Hydrogen peroxide

We reserve the right to knock on the door or enter the pod room when a client has exceeded a reasonable amount of time.

Spa Etiquette –

The float spa is used for relaxation purposes and needs to remain a quiet, tranquil environment. Please make every effort to be respectful and not disturb other clients. Use of cell phones is NOT permitted. Please turn your phone to silent or airplane mode. You may use phone to take pictures.

Late Policy -

It is very important that clients be on time for their appointments. If a client is late (past 20 minutes) and there is an appointment scheduled immediately after (or if they are sharing their appointment time with another client) the client will need to reschedule to avoid scheduling conflicts. Thank you for your understanding.

We require payment for services at the time of service. Currently, cash or credit only is accepted as payment.

I am choosing to use the floatation tank of my own free will and will not hold the owner/operator or Desert Serenity Float liable for any injury during a session or while on the premises. Desert Serenity Float reserves the right to refuse service to anyone.

I hereby agree to irrevocably release and waive any claims that I have now or may have hereafter against Desert Serenity Float and its employees and agents.
